

- Common Commercial Policy
- Exclusive competence of the European Union
- International trade agreements and FDI as a key component of common market

- Mixed agreement involving decision-making process on EU and MS level

FDI screening mechanism

- Targeted on: FDI affecting security and public order in research areas: HORIZON2020, space: GALILEO or trans-European Networks (TENs).
- Instrument of integration: cooperation.
- It is consultation process.
- Independent decision on welcoming FDI by MS.
